AGE

The candidates of 14 years onwards of age as on date of start of admission session are eligible for admission. There is no upper age limit fixed for taking admissions in the course.

COURSE FEES

The fees once paid is non refundable under any circumstances.

SELECTION CRITERIA

Eligible candidates shall be admitted on the basis of Merit and Interview, in each Trade.

EXAMINATION & CERTIFICATION

Exams are conducted directly by NCVT (National Council for Vocational Training, Directorate General of Employment & Training, Ministry of Labour & Employment, Government of India) at the end of the

programme at any venue finalized by them (in the state in which programme is conducted). After the successful completion of the trade, the certificate is also awarded by the NCVT.

APPRENTICESHIP & PLACEMENT

Institute is highly interested to arrange Apprenticeship programme and placement in reputed Industries of our country & abroad, after completion of the course successfully.

ATTENDANCE

A minimum of 75% attendances is compulsory for each programme in Theory / Lectures, Practical, Urban/Rural field visits, to qualify for the final examination.

Admission Procedure



Events And Activities

- Admission is made every year normally in June to August. A candidates seeking admission to any courses of training must get his/her name registered by submitting a duly completed 'REGISTRATION AND ADMISSION APPLICATION FORM', prescribed by the institute along with necessary documents and the request fee. Only one form is required to fill in for consideration of admission to all courses offered by the institute.
- Specific dates are fixed annually in accordance with the training course schedule indicated in the prospectus issued by the MPPITI. Candidates who are admitted to any course in the institute must join within 3 days of starting classes. In case he/she fails to join, his/her name will be deleted and all fees will be forfeited.
- The principal reserves the right to refuse admission to any candidate without assigning any reason what so ever, irrespective of his/her meeting the requirements for admission.
- In all matters related to selection/admission and in the matter of interpretation of the above mentioned clauses, the decision of the management and the principal will be final and binding on all concerned.
- The particulars of prerequisite credential given by candidate if found incorrect, the candidate can be expelled from institute.

FAQS - APPRENTICESHIP TRAINING

1. What is Apprenticeship Training?

Apprenticeship Training is on-the-job training in industry under the provisions of Apprenticeship Act 1961. It comprises (Basic Training, practical Training and Theoretical Classes as per prescribed syllabus.

2. Who can undergo Apprenticeship Training?

A person, who has feted 14 years of age, is physically fit and poses minimum educational qualification prescribed for a trade can undergo Apprenticeship Training. Those passing from Industrial Training Centre in relevant trades get rebate in period of Apprenticeship Training?

3. Where one can undergo Apprenticeship Training?

One can undergo Apprenticeship Training in establishments where seats have been Located in respect of establishments in the state public sector and private sector seats are located 6y the respective state Apprenticeship Advisor and in respect of establishments in the central public sector and departments fading under the Jurisdiction of the Regional Directorate of Apprenticeship Training Centre, Kanpur along with trades in which seats have been located in these establishments is given in table.

4. What is benefit?

The Apprenticeship acquires skiffs, which help them in getting wage or self-employment.

5. Certification after completion Training?

At the end of training the apprentice appear at an ACC India Trade Test Conducted by the National Councilor Vocational Training. Successful apprentices are awarded National Apprentices are awarded National Apprenticeship Certificate, which is recognized qualification for employment.

6. Reservation

Seats are reserved for SC/ST candidates and Persons with Disability.

- 75% attendance is mandatory for appearing for university examination, failing which the term of the student will be cancelled. Attendance will be marked in every lecture and a student who remains absent in one lecture will lose the whole day's attendance. If a student remains absent due to illness, he/she will have to submit a written application along with a medical certificate signed by parents/hostel warden.
- Fees must be paid on the dates announced and at the specified time. Otherwise admission will be cancelled automatically.
- It is compulsory to appear in the internal tests conducted by the college. In case of illness the parents/guardian shall inform the college in writing along with medical certificate, within three days from the commencement of examination.
- The admission of student who bunk lectures and move about in the campus will be cancelled. Irresponsible students will not be admitted to the second term.
- Strictly follow the lab/workshop instructions.
- Student identity card will be issued to all the students and must be carried at all times with his/her photograph affixed on the same and presented for inspection when demanded. No student will be allowed to attend the class practical etc. Unless they have identity card with them.
- No union shall be formed in the Institute. Students shall do nothing either inside or outside the institute that may in any way interface with its orderly working and discipline.
- Conduct of the student in their classes as well as in the premises of the college shall be such as will not cause any disturbance to rest of the students. The principal may expel a student whose work or conduct is not satisfactory and fees will be forfeited.
- Smoking and pan masala chewing are strictly prohibited in the campus. Those who spit pan masala will be punished.
- Strict disciplinary action will be taken against students who misbehave with the college staff or cause damage to college property.
- Ragging is a criminal offence. If any incident of ragging comes to the notice of the college authority, the concerned student shall be given liberty to explain and if his/her explanation is not found satisfactory. College authority would expel him/her from the college.
- Absence without leave is considered as a breach of discipline and leave without permission is liable to fine. No leave will be granted without previous written application except, in case of emergency. Prior permission must be obtained for all other leaves and the application will be considered by the principal on the individual merit.
